Tree Limbs and Brush Removal

The City will pick up tree limbs and brush provided brush and limbs are cut into 4-6 foot lengths and tied into bundles weighing less than 65 pounds and not larger than 4 feet high and placed at the curb. Contact the Public Works Department at 594-3734 for pickup. Items that do not meet these requirements will be refused.

Alley Maintenance

On request, the Public Works Department will grade alleys at no charge. However, there is a charge to provide rock. The charge will be \$4.00 per ton over the current price of rock. This charge is to cover our expense for hauling and spreading the rock.

Storm Drainage Areas

On request and after review by the Public Works Director, consideration will be given to installing culverts in ditches for driveways, provided the property owner pays for the materials required. The property owner will install the culvert according to specifications provided by the Public Works Director.

Sidewalk Removal on City Right of Way

It is the owner's responsibility to maintain the sidewalk on the City's right-of-way. An application must be made to have the City crews break up and remove the sidewalk.

In order to encourage property owners to keep this sidewalk in proper repair, there is no charge to have the City crews remove the sidewalk that is located in the right-of-way. This removal does include hauling away. The sidewalk must be replaced by the property owner.

Sign Replacement Charges

Sign replacement or repair due to accidents, vandalism, etc. will be charged at cost plus freight plus a \$5.00 handling fee.

Labor will be charged out at \$25.00 per sign repair whether complete post replacement is needed or not, since approximately the same amount of time is involved.
